Transformation i.e. improving the way services are delivered will get underway after that point in time but in the short term there should be no change in the way the public interacts with the council for most services. The Shadow Executive met on 14 January and endorsed the constitution. The next meeting of the Shadow Dorset Council is scheduled to take place on Thursday 24 January at 1830. The tier 2 (Directors) management appointments has been reported in the newsletters sent to the Parish Councils.
